NOTICE OF INTENTION TO EXPROPRIATE

1. TAKE NOTICE THAT The Town of Westlock intends to expropriate the northerly Eighty (80.0) acres, more or less (and as identified in red on the plan attached hereto as Schedule "A"), of the following lands:

THE NORTH EAST QUARTER OF SECTION THIRTY THREE (33)
TOWNSHIP FIFTY NINE (59)
RANGE TWENTY SIX (26)
WEST OF THE FOURTH MERIDIAN
CONTAINING 64.7 HECTARES (160 ACRES) MORE OR LESS.
EXCEPTING THEREOUT: HECTARES ACRES MORE OR LESS
A. PLAN 7721021 - ROAD 0.979 2.42
EXCEPTING THEREOUT ALL MINES AND MINERALS

2. The nature of the interest in the lands intended to be expropriated is fee simple, and including any registered or unregistered leasehold or other interests, and including the registered interest of Plains Western Gas & Electric Co. Ltd.(Alta-Gas Utilities), as to an Easement, in so far as it may be affected, and the registered interest of Marvin Marks, as to a Caveat, in so far as it may be affected.

3. The work or purpose for which the interest in the lands is required is for the development of an industrial - commercial park.

4. Section 6 of the *Expropriation Act* provides that:

(1) No person may in any proceedings under this Act dispute the right of an expropriating authority to have recourse to expropriation.

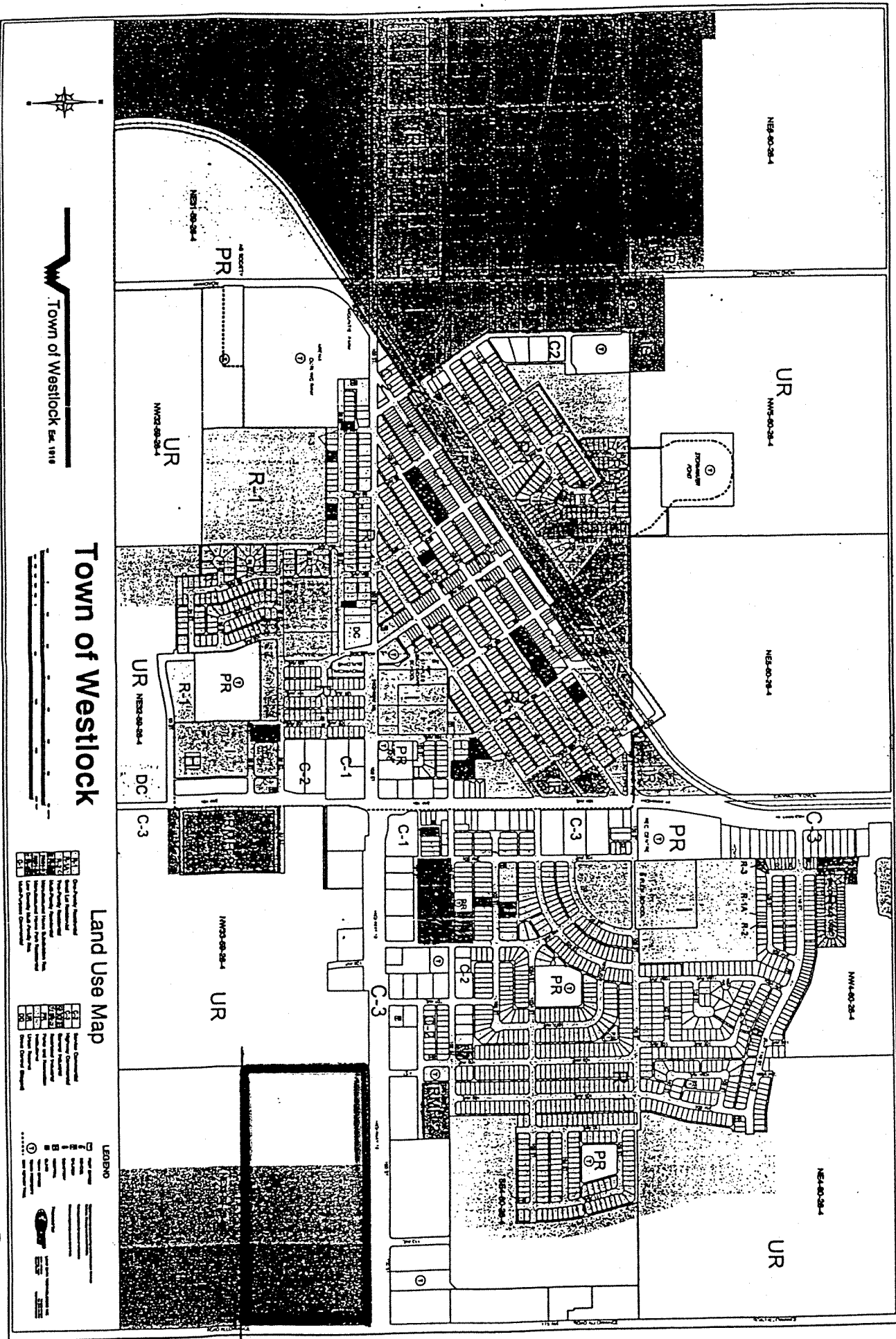
(2) In any proceedings under this Act the owner may question whether the taking of the land, or the estate or interest therein, is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority.

5. Section 10 of the *Expropriation Act* provides that:

(1) An owner who desires an inquiry shall serve the approving authority with a notice of objection,

(a) in the case of an owner served in accordance with section 8(2), within 21 days of service on him of the notice of intention, and

(b) in any other case, within 21 days after the first publication of the notice of intention.

(2) The notice of objection shall state:

- (a) the name and address of the person objecting,
- (b) the nature of the objection,
- (c) the grounds on which the objection is based, and
- (d) the nature of the interest of the person objecting.

6. A person affected by the proposed expropriation does not need to serve an objection to the expropriation in order to preserve his right to have the amount of compensation payable determined by the Land Compensation Board or the Court of Queen's Bench of Alberta, as the case may be.
