NOTICE OF OBJECTION

1. TAKE NOTICE THAT, MARVIN D. MARKS of 10545 - 100 Street, Westlock, Alberta, T7P 2G7, the registered owner of the hereinafter described lands, hereby objects to the proposed expropriation of the said lands by the Town of Westlock:
